

**ADDENDUM TO CONTESTANT'S CONTRACT WITH**  
THE MISS UNIVERSITY OF GEORGIA COMPETITION  
Scholarship Rules and Regulations

This addendum will become part of the original contract signed by  
(name) \_\_\_\_\_, a participant in  
the  
2022 Miss University of Georgia Scholarship Competition.

1. If selected as the Winner of the "2022 Miss University of Georgia Competition":
  - a. I understand if I choose to use the services of a coach for talent or personal grooming, I will consult with and/or obtain approval of the Miss UGA Committee.
  - b. I will serve as "Miss University of Georgia" until my successor is selected or appointed.
  - c. I will notify the Pageant Advisor of any and all requests for public appearances made as "Miss University of Georgia" or as an official representative of The University of Georgia. The Miss UGA Advisor will, in effect, become the agent for "Miss University of Georgia". In addition, I will notify the Miss UGA Advisor in advance if I choose to compete in any other Miss America Preliminary competition.
  - d. I will schedule, within two weeks of being crowned, an appointment to have a portrait photo session with the pageant photographer (consult with Jerry Anthony). Final selection of the photographer and photos, to be used in the Miss Georgia Program Book, will be approved by the Miss UGA Director and Committee.
  - e. I will obtain approval from the Miss UGA Director and Committee, for the contestant fact sheet, wardrobe and talent selection prior to going to the Miss Georgia Competition.
  - f. I will make myself available for personal appearances, interviews, testimonials, endorsements, filming, and other such commitments and events that the Miss UGA Committee has made or will make for me whenever said appearance does not conflict with the furtherance of my education or employment. In addition I will meet on a regular basis (weekly or bi-weekly) with the Miss UGA Director and/or Committee.
  - g. I will make myself available to assist with, including attending committee meetings and rehearsals, the 2023 Miss University of Georgia Competition.
  - h. I will attend the Miss Georgia Forum Weekend held March 2022 (exact dates TBD). This is the official orientation weekend of activities required for all contestants.
  - i. I will attend a Miss Georgia orientation meeting (if necessary) at the location to be determined by the Miss Georgia pageant. \*

- j. I will represent The University of Georgia at the 2022 Miss Georgia Pageant, held in June, 2022. (specific date and location TBD).

### SCHOLARSHIP RULES AND REGULATIONS

2. If selected as first, second, third, or fourth runner-up to the title of "Miss University of Georgia", I agree to be available to succeed to all the rights (including any forfeited scholarship) and to assume all of the duties and obligations of this title as set forth herein, if for any reason the original "Miss University of Georgia" or prior runners-up are unable or ineligible to act as "Miss University of Georgia 2022".

As a scholarship winner in the Miss University of Georgia Competition I understand and accept the scholarship regulations as outlined below:

1. Scholarships shall be expended for tuition and related expenses, such as room, board and other educational expenses as approved by the Miss Georgia Scholarship Committee.
2. Contestants must use the scholarships won at the local level prior to receiving scholarships at the Miss Georgia level.
3. Scholarships may be used for outstanding student loan obligations provided the loan is not in default and provided the student has satisfactorily completed the course work for which the loan was obtained.
4. Scholarships may be used for future educational expenses within the time limitations specified herein:
  - a. A contestant must begin use of her scholarship within 1 year (2 years for Miss Georgia) of the date of the award. If a contestant has no activity in her scholarship account during this period, the funds in her account will be forfeited.
  - b. A contestant who begins use of her scholarship within the time designated above will then be required to show continuous activity in her scholarship endeavors up to a limit of 2 years (3 years for Miss Georgia) following the date of the award. If there occurs a 1 year period in which there is not activity in the account, the balance of that account will be forfeited.
  - c. The scholarship must be used while attending The University of Georgia (unless approved by the Pageant Dir).
5. The winner and runners-up must be currently enrolled at the University of Georgia at the time the scholarship is paid.
6. The winners and runners-up must be academically eligible, as required by the University of Georgia to receive a scholarship.
7. The winner must be eligible to hold the title of Miss UGA. She must meet all requirements set forth in the contract, as required by Miss Georgia and Miss America guidelines.
8. The winner's scholarship will be awarded over two semesters (spring and fall) in equal payments (unless changed by the Pageant Dir). The payment will go directly to the student account as issued by the University of Georgia Financial Aid Office (unless otherwise directed by the Pageant Dir).
9. The first runner-up scholarship will be awarded spring semester The payment will go directly to the student account as issued by the University of Georgia Financial Aid Office (unless otherwise directed by the Pageant Dir).

10. The other scholarships (runners up, People's Choice, and Congeniality) will be awarded spring semester. The payment will go directly to the student account as issued by the University of Georgia Financial Aid Office (unless otherwise directed by the Pageant Dir).
11. No cash awards will be made in lieu of scholarship.

12. Scholarships to be awarded for the 2020 Miss University of Georgia Competition include:

Winner:	To Be Determined but no less than \$1,000
First Runner-up:	\$ 650.00
Second Runner-up:	\$ 500.00
Third Runner-up:	\$ 350.00
Fourth Runner-up:	\$ 250.00
People's Choice	TBA – based on voting income on pageant night

The guidelines and regulations have been effective since June 14, 1993 and will continue until any changes are made by the Miss Georgia and/or Miss America Organization.

The Miss University of Georgia Committee will provide the following additional support to the title holder of "Miss University of Georgia":

1. Miss University of Georgia will be required to attend the Miss Georgia Forum Weekend and lodging will be provided, as arranged by the Pageant Director.
2. Miss University of Georgia may be required to attend an orientation day or paperwork follow up meeting to be held during late spring if necessary. The program will begin early on Saturday morning and will end the same day for the purpose of submitting all required forms and documents.
3. The Miss UGA Committee will provide payment for the required outfit if the Miss Georgia Competition opening number requires that all contestants wear the same outfit. All competition outfits should be shown to the Miss UGA Committee but UGA will not pay for any additional outfits other than opening number.
4. The Miss Georgia Competition will provide some expenses for the Miss Georgia Week, including meals and local transportation during pageant events. The contestant must provide her own transportation to/from the host city and pay for lodging expenses.

If I am awarded a scholarship by the Miss University of Georgia Competition I, \_\_\_\_\_, consent for the Office of Student Financial Aid to share the information on my Miss America Scholarship expenditures with the Office of the Vice President for Student Affairs who will provide the information to the Miss America Program.
